A Bill to Establish Postal Banking in the United States

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. To provide affordable and accessible financial services to all residents, the
 United States Postal Service (USPS) shall establish a postal banking system.
- SECTION 2. "Postal Banking System" shall refer to basic financial services, including
 small savings accounts, check cashing, remittance services, and small-dollar
 loans, through USPS post offices.
- Frame Section 3. The USPS shall be responsible for establishing and maintaining the postal banking system, in collaboration with the Department of the Treasury and the Federal Reserve System.
- A. The USPS shall also establish rules and regulations for the operation of the system,
 including risk management and consumer protection measures.
- B. The USPS shall also be subject to the provisions of Article 4 of the Uniform

 Commercial Code, and shall not be granted a bank charter or become an insured depository institution.
- 14 C. The USPS shall have the authority to assess fees for its services, subject to approval by the Postal Regulatory Commission.

- D. The USPS shall also have the authority to issue postal banking bonds, backed by the full faith and credit of the United States, to finance its operations.
 - E. Savings accounts are not to exceed \$20,000 per account and small- dollar loans shall not exceed \$500 at a time. The USPS may not issue more than \$1000 in small dollar loans per person per year.
- SECTION 4. The funding for this bill shall be \$10 billion as a startup cost, and then shall
 fund itself through fees generated.
- SECTION 5. This legislation shall take effect on Jan 1, 2026. All laws in conflict with this
 legislation are hereby declared null and void.

A Resolution to Amend the Constitution to Lower the Age of Candidacy for the Presidency of the United States

1	RESOLVED,	By two-thirds	s of the Congress here assembled, that the following article is
2		proposed as a	an amendment to the Constitution of the United States, which
3		shall be valid	to all intents and purposes as part of the Constitution when
4		ratified by the	e legislatures of three-fourths of the several states within
5		seven years f	rom the date of its submission by the Congress:
6			ARTICLE
7		SECTION 1:	That Article II, Section 1, paragraph 5 shall be amended to
8			read: "No Person except a natural born Citizen shall be
9			eligible to the Office of President; neither shall any Person
10			be eligible to that Office who shall not have attained to the
11			Age of twenty five Years or have exceeded the age of
12			seventy five Years unless they shall have been elected before
13			attaining the age of seventy five years, and been fourteen
14			Years a Resident within the United States."
15		SECTION 2:	The Congress shall have power to enforce this article by
16			appropriate legislation.

A Resolution to Use Bamboo as an Alternative to Hardwood

THIS CONGRESS HERE ASSEMBLED BELIEVES THAT:

- 1. **WHEREAS**, Deforestation has become an increasing issue.
- 2. WHEREAS, The entire world is affected by this problem and something needs to be
- 3. done.
- 4. WHEREAS, Deforestation has been increasing the issue of the climate crisis, harming
- 5. animal habitats, and creating environmental issues for humans.
- 6. **RESOLVED**, By this congress here assembled that: the future use of hardwood ought to
- 7. be replaced with the use of bamboo.
- 8. ARTICLE:
- 9. **SECTION 1.** The United States Department of Agriculture(USDA) shall oversee 13 the
- 10. import of bamboo. The United States Department of 14 Agriculture(USDA), the U.S.
- 11. Forest Service, and the U.S. 15 Environmental protection agency(EPA) shall oversee the
- 12. use and 16 farming of bamboo.

A Bill to Make Citizenship More Accessible

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	A. The United States Government shall reduce the Citizenship Application
2		processing fee from \$640 to \$300, bringing the total cost of applying for
3		citizenship to \$385.
4		B. 50% of this new application fee shall go to establishing free citizenship
5		preparation classes at local community colleges.
6		C. The Civics section of the Naturalization Test shall also be revised to
7		replace arbitrary questions with more relevant logic-based questions.
8	SECTION 2.	A. Free citizenship preparation classes shall cover all things an applicant
9		would need to know in order to participate as a citizen in the United States.
10		This includes:
11		1. A basic understanding of how to speak, read, write, and listen to
12		the English language, and
13		2. A knowledge of U.S civics which includes history, government, and
14		current events.
15		B. "Arbitrary questions" on the Naturalization Test shall be defined as any
16		question that requires an applicant to recall specific dates, irrelevant
17		historical figures, or unimportant facts about U.S. history and the
18		government. Questions should instead focus on why events or government
19		systems were put in place instead of when.
20	SECTION 3.	The Department of Homeland Security will be in charge of funding,
21		overseeing, and enforcing this bill.
22	SECTION 4.	This legislation will take effect July 4th, 2024. All laws in conflict with this
23		legislation are hereby declared null and void.

Introduced for Congressional Debate by Okoboji High School.

A Bill to Reduce and Prevent Gun Deaths in the United States

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1. **SECTION 1**. The sale, manufacture, modification, and possession of fully automatic and semi-automatic firearms for civilians
- 2. will be prohibited. High-capacity magazines will be banned. Semi-automatic (but not fully automatic) handguns, such as
- 3. pistols or revolvers, shall be exempt from this ban. Hunters, sport shooters, or others participating in activities using the
- 4. firearms banned will be allowed to for a special license from the ATF to possess/use the firearms banned.
- 5. **SECTION 2.** Semi-automatic and fully automatic firearms will be defined as any rifle, shotgun, or other firearm capable of one
- 6. round or a burst of several rounds fired with each trigger depression or a constant discharge of rounds as long as the trigger is
- 7. depressed. The modification or use of attachments on previously non-automatic firearms into semi-automatic or fully
- 8. automatic firearms will also be prohibited (such as the use of "bump stocks", gun "switches", or any other methods).
- 9. High-capacity magazines will be defined as any magazine, belt, drum, feed strip, or similar device that has the capacity of, or
- 10. that can be readily restored or converted to accept, more than 10 rounds of ammunition.
- 11. **SECTION 3.** This bill will be enforced by the Bureau of Alcohol, Tobacco, and Firearms (ATF), in
- 12. cooperation with local law enforcement.
- 13. **3A.** \$2 billion will be transferred from the defense budget and moved to the ATF to fund this bill.
- 3B. Prohibited firearms or magazines already owned by the time the bill comes into effect will be repurchased fromowners by the ATF and disposed of. The purchases will be made at police stations.
- 3C. The formation of a committee, board, or other such organization in order to further define banned or acceptablefirearms by specific gun models will be overseen by the ATF.
- 18. **3D.** In order to obtain a special license for firearms, the applicant must prove a need for such a firearm in their activity,
- 19. have a mental health examination a background check, and will be required to renew the license annually. Further
- 20. details will be decided by the organization as stated in Section 3C.
- 21. **SECTION 4.** This legislation will take effect on July 1, 2024. All laws in conflict with this legislation are hereby declared null and
- 22. void.

A Resolution to Fix the Digital Divide in Schools to [Provide Equal Internet Access to Students]

- 1. WHEREAS, While technology is advancing, there are still many students in our education
- 2. system who lack access to the internet.
- 3. WHEREAS, According to Harvard Business Law, the digital divide is defined as "... the gap
- 4. between those who have access to reliable internet service and those who don't, the
- 5. true nature and extent of the divide is often under-appreciated. Students all over the
- 6. United States are not getting equal access to the internet like they should.
- 7. WHEREAS, Thousands of students do not have access to wifi or even the technology to
- 8. be able to do their schoolwork and be successful in school because resources are not
- 9. being allocated equally.
- 10. WHEREAS, In the status quo, education is continuously becoming more and more
- 11. digital especially after the Covid-19 era.
- 12. RESOLVED, That the Congress here assembled should increase the affordability of
- 13. internet for school districts, and allocate 40,000 dollars from the United States
- 14. education budget to school districts in need.

A Bill To Require Paid Parental Leave

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1.** Businesses shall be federally required to provide paid family leave for both
- 3 part-time and full-time employees for a minimum of 6 weeks.
- 4 **SECTION 2.** Definitions
- 5 A. A business is defined as any employer with 10 or more employees.
- B. A part-time employee is defined as any employee who works under 40 hours per
- 7 week, and/or any seasonal employee. A full-time employee is defined as any employee
- 8 who works 40 or more hours per week.
- 9 C. Parental leave is defined as any time taken off of work due to the birth of a child for
- either the employee or their spouse, or adoption of a child.
- D. Paid leave will be determined by the average hourly wage received within the last
- month. For reference, an employee who works 40 hours per week for a wage of \$15 per
- hour who takes 6 weeks of leave would receive \$3,600 over the course of the leave.
- 14 **SECTION 3.** Businesses who do not comply with this requirement will be fined an amount
- 15 equivalent to 200% of said unpaid employee's weekly earnings per week of unpaid leave.
- 16 **SECTION 4.** This legislature shall take effect at the start of the next fiscal quarter. All laws
- 17 in conflict with this legislation will be declared null and void.

A Bill to Reinstate Basic Reproductive Rights

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	All of those with female reproductive organs in the United States shall be
2		guaranteed the right to a safe and medically supervised abortion.
3	SECTION 2.	Those with female reproductive organs can include but is not limited to
4		those who identify as women, as well as:
5		A. Trans men
6		B. Intersexed individuals
7	SECTION 3.	The U.S. Department of Health and Human Services will insure:
8		A. Training programs for doctors will include standardized information on
9		safe and humane abortion procedures
10		B. Each abortion will be performed in a safe and sanitary clinic or health
11		office and will be performed by a licensed professional
12	SECTION 4.	The National Association of Insurance Commissioners will insure:
13		C. That every legal abortion performed will be free of cost to the patient
14		and will be paid for by insurance companies
15		a. Each abortion that is covered by insurance must be performed
16		on a patient that has health insurance
17		D. If a company is found in violation they will be charged a fine of 100,000
18		USD for every instance
19	SECTION 5.	The provisions of this bill shall be in effect by January 1st 2025.
20	SECTION 6.	All laws in conflict with the provisions of this bill shall be declared null and
21		void.

A Bill to Increase Pay for First Responders

Be it enacted by the IHSSA Student Congress assembled that:

- 1. **Section 1:** All First Responders in lowa will have their pay increased equally by the
- 2. increase of the lowa sales tax of 1% (b) This increase of pay shall apply to all workers
- considered First Responders, including but not limited to Fire, Police, and EMS.
- 4. **Section 2a:** First Responders shall be defined as, someone designated or trained to
- 5. respond to an emergency, including but not limited to Fire, Police, EMS, Lifeguards, and
- 6. DNR officer. Does not include privately funded businesses or corporations.
- 7. Section 2b: Equal pay increase shall be defined as, a 5% increase in the hourly pay of
- 8. the worker.
- 9. Section 2c: Government funded shall be defined as, a service, business, or institution
- 10. receiving money from the local, state, or federal government.
- 11. **Section 2d:** Temporary cut in funding shall be defined as, a 1-3 month period without
- 12. the use of funding provided by the local, state, or federal government.
- 13. Section 3: The Iowa Treasury Department shall be responsible for enforcing the
- 14. provisions of this Act.
- 15. The lowa Department of Treasury shall have the authority to oversee the pay of the First
- 16. Responders and ensure all government funded First Responders receive the equal \
- 17. increase of pay without without discrimination Institutions found in violation of this
- 18. prohibition shall be subject to the following penalties:
- 19. i. Temporary cut in funding without affect to the workers pay till pay is fixed
- 20. **ii.** Retraining of proper procedures to be completed before work can continue
- 21. Section 4: All laws in conflict with this legislation are hereby declared null and void.
- 22. **Section 5:** This Act shall take effect 1st January 2025.

A Bill to Establish a Universal Basic Income to Eliminate Poverty in the United States

1	BE IT ENAC	TED BY THE CONGRESS HERE ASSEMBLED THAT:
2	Section 1.	Every United States citizen residing in the United States above the age of
3		eighteen years, shall receive one thousand dollars per month. This will be
4		paid for by a ten percent value added tax.
6	Section 2.	Value added tax shall be defined as a consumption tax on goods and
7		Services that is levied at each stage of the supply chain where value is
8		added, from initial production to the point of sale.
9	Section 3.	The United States Department of the Treasury will oversee the collection
10		of the revenue from the value added tax (VAT). The United States
11		Department of the Treasury will oversee and be responsible for the
12		distribution of the universal basic income.
13	Section 4.	This legislation will take effect starting in Fiscal Year 2025. All laws in
14		conflict with this legislation are hereby declared null and void.

A Bill to Increase Funding to Nuclear Fusion Research

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

- 1. **Section 1** The United States federal government shall begin funding
- 2. nuclear fusion program.
- 3. **Section 2** Nuclear Fusion is defined as the process of two smaller atoms
- 4. combining into a larger atom that produces a considerable amount of energy.
- 5. **Section 3** The Nuclear Regulatory Commission will oversee the
- 6. implementation of this piece of legislation.
- 7. **A:** An allocation of 20,000,000,000\$ USD will be given for research
- 8. funding.
- 9. **B:** The Nuclear Regulatory Commission will use the monetary funding in
- 10. accordance with private researchers.
- 11. **C:** Once the Nuclear Regulatory Commission is prepared to build a
- 12. prototype fusion reactor an additional 15,000,000,000\$ USD will be
- 13. allocated to finance the creation of such a prototype.
- 14. **Section 4** This piece of legislation will be implemented January 1st 2025.
- 15. **Section 5** All other laws in conflict are hereby declared null and void.

A BILL TO PROTECT THE OWNERSHIP OF PIT BULLS, ROTTWEILERS, AND OTHER DOG BREEDS IN IOWA

By Norwalk High School

BE IT ENACTED BY THE IHSSA STUDENT CONGRESS:

Section 1: A city in the state of Iowa shall not adopt, enforce, or otherwise administer
 an ordinance, motion, resolution, or amendment that restricts or hinders a person's
 right to own or keep a dog based on the breed, perceived breed, or physical
 characteristics of the dog. This section does not inhibit the authority of a city to adopt,
 enforce or administer an ordinance, motion, resolution, or amendment that applies to all dogs.

6 **Section 2:** This act is effective June 30, 2024.

Death with Dignity Act

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1. Section 1: If the congress assembled here today decides to pass this bill then physicians will be able to
- 2. prescribe a lethal dose of sodium thiopental and cisatracurium besylate to patients who are mentally
- 3. competent, 18 or older, terminally ill with 6 or fewer months to live, have gone through all other available
- 4. options, and have requested the procedure.
- 5. Section 2: Sodium thiopental is a barbiturate anesthetic, which is supposed to induce deep
- 6. unconsciousness in around 20 seconds. (National Library of Medicine). Cisatracurium besylate is an
- 7. intermediate-acting no-depolarizing neuromuscular blocking drug (NMBD)(National Library of Medicine). A
- 8. dose is the measured quantity of a therapeutic agent to be taken at one time (Merriam-Webster) Lethal is
- 9. defined as deadly, mortal, and fatal (Black Law's Dictionary). Mental competence is defined as the ability to
- 10. understand the nature and effect of the act in which a person is engaged. (Black Law's Dictionary) A
- 11. physician is a practitioner of medicine. (Black Law's Dictionary)

12. Section 3:

- 13. **3A:** If passed the Food and Drug Administration (FDA) will oversee and enforce this legislation:
- 14. \$5,000,000 will be allocated to the FDA for, enforcing the scientific studies pertaining to the
- 15. drugs and production of the drugs
- 16. **3B:** As well as this, The National Institute of Health, will oversee the protection of a patient's right to
- 17. the procedure based on if they meet all of the requirements.
- 18. Section 4: This legislation shall take effect on January 1, 2025. All laws in conflict with this legislation are
- 19. hereby null and void.

Introduced for Congressional debate by Atlantic High School.

A Bill to Legalize the Use of Psychedelic Therapy

Be it enacted by the IHSSA Student Congress assembled here that:

- 1. **Section 1:** Psychedelic Therapy will be legalized for medical use only.
- 2. Section 2: Psychedelic Therapy may consist of any of the following: Psilocybin, MDMA,
- 3. LSD, and Ayahuasca
- 4. Section 3: All therapies must be done in a controlled environment such as an accredited
- 5. hospital or clinic.
- 6. Section 4: Prior to starting psychedelic therapy, a person must try at least two other
- 7. types of therapies first, and they must have referrals from two doctors for psychedelic
- 8. therapy.
- 9. **Section 5:** The FDA and the CDC will oversee these programs.
- 10. Section 6: Any doctor who refuses to perform psychedelic therapy will have their license
- 11. revoked and fined \$1,000.
- 12. Section 7: Any hospital that refuses to perform psychedelic therapy will be fined
- 13. \$50,000.
- 14. Section 8: Insurance companies will cover the psychedelic therapy based on what that
- 15. the specific insurance company would cover any other type of therapy.
- 16. Section 9: Current laws still apply to the use of psychedelic therapy outside of these
- 17. controlled environments.
- 18. Section 10: Any laws in conflict with this legislation are hereby null and void.
- 19. Section 11: This bill will go into effect January 1st, 2025

A Bill to Legalize Horse Meat for Human Consumption to Provide an Alternative Meat Source for Lean Protein

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

a SECTION 1	All bans in place on the claughter cale, and human consumption of barse
2 SECTION 1.	All bans in place on the slaughter, sale, and human consumption of horse
3	meat within the United States are hereby lifted; federal inspections of
4	horse-meat slaughterhouses are hereby mandated and shall require the
5	use of federal funds for these mandatory inspections.
6 SECTION 2.	"Human consumption" means processing meat in a manner consistent
7	with established federal procedures for edible products for humans.
8	"Federal inspections" means monitoring the manufacturers of
9	FDA-regulated products.
10	"Alternative Meat Source" means a source of meat not generally
11	consumed in the United States.
12	"Lean" is defined by the USDA as having less than 10 grams of total fat
13	per 3.5 ounce portion.
14	"Protein" is an essential macronutrient that is a key part of any diet and
15	can be plant- or animal-based.
16 SECTION 3.	The Food and Drug Administration will oversee inspections and
17	enforcement.
18	A. Federal funding for horse-meat slaughterhouse inspections will be
19	allocated from the current FDA inspections budget.
20 SECTION 4.	This legislation will take effect for FY 2028. All laws in conflict with this
21	legislation are hereby declared null and void.

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 **SECTION 1**. All public high schools should offer American sign-language
- 2 as a graduation requirement for world languages.
- 3 **SECTION 2**. ASL is American Sign Language, which is the primary language
- 4 of the deaf community in North America.
- 5 **SECTION 3.** The Department of Education will Enforce this bill.
- 6 **SECTION 4.** This legislation will take effect in January 1 2025.
- 7 All laws in conflict with this legislation are hereby declared null and void.

A Bill to Reform the Cash-Bail System

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1. **SECTION 1**. The United States Justice System will reform the cash-bail system so that
- 2. only defendants charged with a felony will participate in the cash-bail system.
- 3. **SECTION 2**. The cash-bail system is described as the process in which defendants are
- 4. given a certain monetary value to pay that allows them to leave jail before their trial and
- 5. also guarantees their appearance at trial. Those not able to pay are obligated to wait in a
- 6. jail facility before their trial. A felony is defined as the highest degree of crime with
- 7. punishments that can include execution, prison, or probation. All degrees of crime below
- 8. felonies are known as misdemeanors and infractions. Misdemeanors are second-degree
- 9. crimes that can lead to incarceration, probation, or fine. Infractions are the lowest
- 10. degree of crime and are generally through fines.
- 11. **SECTION 3.** The United States Department of Justice will oversee this bill.
- 12. **A.** The U.S. Marshals Service will be responsible for the execution and
- 13. protection of this bill
- 14. **SECTION 4.** This legislation will take effect on July 1, 2024. All laws in conflict with this
- 15. legislation are hereby declared null and void.

A Bill to Federally Allow the Ownership of Backyard Chickens

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT
- 2 **SECTION 1.** The keeping of chickens on residential property within city limits shall be
- 3 permitted provided the habitat and enclosure meet the requirements set forth in section 2 of this bill
- 4 **SECTION 2**. Requirements
- 5 A. Owners shall be required to have a coop of no smaller than 3 square feet per chicken at minimum
- 6 B. Owners shall be required to allocate a minimum of 8 square feet per chicken of enclosed grass space.
- 7 C. Owners shall be required to possess a well-tended compost bin.
- D. Owners shall not be permitted to keep a rooster unless both of the following requirements are met
- 9 a. They have 10 or more chickens.
- b. They live in a town of no more than 1000 people.
- 11 E. Owners shall be required to obtain a permit every 5 years through the United States
- Department of Agriculture. To obtain a permit they must provide documentation that their place of
- residence meets the requirements outlined in section 2A, 2B, and 2C.
- 14 **SECTION 3.** Definitions
- 15 A. A coop is defined as a small enclosed area in which chickens are kept, which includes nesting boxes.
- B. Enclosed grass space is defined as a level grassy area free of large objects which is enclosed by a fence
- 17 **SECTION 4.** If any one person is found in violation of any of the requirements listed in
- 18 section 2, they will be subject to a minimum fine of \$150 up to a maximum of \$500 per
- 19 violations. Repeated violations can result in the revocation of licensure, at the discretion of
- 20 local law enforcement.
- 21 **SECTION 5.** This legislation shall take effect on January 1, 2025. All laws in conflict with
- 22 this legislation will be declared null and void.

A BILL TO BAN TIKTOK IN IOWA

By Norwalk High School (9th Grade)

BE IT ENACTED BY THE IHSSA STUDENT CONGRESS:

- 1 **Section 1:** TikTok may not operate within the territorial jurisdiction of Iowa. An entity violates 2 this prohibition when any of the following occurs within the territorial jurisdiction of Iowa:
- 3 (A) the operation of TikTok by the company or users; or
- 4 (B) the option to download the TikTok mobile application by a mobile application store.
- 5 **Section 2:** An entity that violates a provision in Section 1 is liable in the amount of \$10,000 for 6 each discrete violation and is liable for an additional \$10,000 each day thereafter that the violation 7 continues.
- 8 **Section 3:** Penalties in Section 2 do not apply to the users of TikTok.
- 9 **Section 4:** This act is void if TikTok is acquired or sold to a company that is not incorporated in 10 any other country designated as a foreign adversary in 15 C. F. R. 7. 4 at the time TikTok is sold 11 or acquired.
- 12 **Section 5:** As used in this act, the following definitions apply:
- 13 (A) "Discrete violation" means each time that a user accesses TikTok, is offered the ability to
- 14 access TikTok or is offered the ability to download TikTok.
- 15 (B) "Entity" means a mobile application store or TikTok.
- 16 (C)"Mobile application" means a type of software program designed to run on a mobile
- 17 device.
- 18 (D) "TikTok" means the social networking service owned by the Chinese company
- 19 ByteDance limited or any successor.
- 20 **Section 6:** This act is effective January 1, 2025.

A Bill Relating to Disability Education in Iowa Secondary Schools

Be it enacted by the IHSSA Student Congress assembled that:

- 1. **Section 1:** The purpose of this bill is to promote awareness and understanding of disabilities among
- 2. secondary school students in Iowa and to create an inclusive and accepting environments for all
- 3. students, including those with disabilities. This bill aims to foster empathy, tolerance, and the inclusion
- 4. of individuals with disabilities in the secondary school community.
- 5. **Section 2a:** All public secondary schools in the state of lowa shall include disability education as part of
- 6. the curriculum, to be completed annually within the first 60 days of the school year.
- 7. **Section 2b:** Disability education shall cover a wide range of topics, including but not limited to the
- 8. following: Understanding various types of disabilities. Promoting empathy, respect, and inclusion of
- 9. individuals with disabilities. Learning about available resources and support services for students with
- 10. disabilities. Practical skills to interact with and assist individuals with disabilities.
- 11. **Section 3:** Schools shall incorporate disability education into an advisory time during the first 60 days
- 12. of the school year. The lowa Department of Education shall develop guidelines and resources to
- 13. support the implementation of disability education in secondary schools.
- 14. **Section 4:** The lowa Department of Education shall establish a system for monitoring and reporting
- 15. on the implementation of disability education programs in secondary schools. Schools shall report
- 16. on their disability education activities and outcomes, including data on student participation and the
- 17. impact on the school community.
- 18. **Section 5:** The state shall allocate funding specifically for the development and implementation of first
- 19. disability education programs in secondary schools. (b) Funding shall be allocated annually within the
- 20. 60 days of the school year to support teacher training, curriculum development, and the purchase of
- 21. educational materials related to disability education.
- 22. **Section 6:** All laws in conflict will become null and void.
- 23. **Section 7:** This bill shall take effect at the beginning of the academic year following its passage Introduced for Congressional Debate by Hempstead High School.

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

A BILL REQUIRING STATE GOVERNMENTS TO BAN THE SALE AND USE OF ENERGY DRINKS TO INDIVIDUAL 18 YEARS OF AGE AND YOUNGER

By Norwalk High School

BE IT ENACTED BY THE IHSSA STUDENT CONGRESS:

- 1 **Section 1:** Effective January 1st, 2026, all state governments must ban the sale and use of energy 2 drinks to individuals 18 years of age and younger.
- 3 Section 2: Energy drinks are defined as a beverage with a blend of caffeine, taurine,
- 4 glucuronolactone, guarana, L-carnitine, and added sugars.
- 5 **Section 3:** State governments out of compliance with this law will lose 8% of federal funding for 6 the Children's Health Insurance Program (CHIP) and Medicaid.

A Bill for the Creation of the Zero Act of 2024

Be it enacted by the IHSSA Student Congress that:

- 1. **Section 1:** All therapies for human trafficking victims will be free of charge.
- 2. **Section 2:** Insurance companies will cover the same percentage of all therapies in
- 3. regard to human trafficking victims as they would for anyone prescribed these therapies.
- 4. The percentage paid for human trafficking victims must be at least 50%. This will not
- 5. increase the insurance premiums for anyone.
- 6. **Section 3:** All prisoners convicted of human trafficking will be required to work some
- 7. kind of 40 hr/week job, where they will donate at least 50% of their paycheck to a fund to
- 8. cover the remainder of human trafficking victims' therapies.
- 9. Section 4: When a human trafficking ring is discovered and dissolved, the money that
- 10. the trafficking ring stored to further its trafficking will automatically be placed into this fund.
- 11. **Section 5**: Anyone has the ability to donate money to this fund by contacting DHS.
- 12. **Section 6:** The Department of Health and Human Services will oversee this program.
- 13. Section 7: Any insurance company that doesn't comply with these standards will be
- 14. imposed a \$100,000 fine for each session not paid for, which will go into this therapy fund.
- 15. **Section 8:** All laws in conflict will become null and void.
- 16. Section 9: This bill will go into effect July 1st, 2024.

A Bill to Federally Monitor Cryptocurrency

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	The United States Federal Government will begin the process of
2		authenticating and monitoring the use of digital wallets by expanding the
3		Bank Secrecy Act (BSA).
4	SECTION 2.	Expansion of BSA will include :
5		A. Eliminating unhosted wallets which bypass Anti-Money Laundering
6		sanctions.
7		B. Verify customers by requiring registration with FinCEN, SEC, and
8		CFTC, depending on the nature of the assets.
9		C. Requiring all cryptocurrencies to file as exchange institutions with

12		A. The Federal Reserve System and the FDIC will receive two billion

A Bill to Establish a Federal Cap and Trade System for Carbon Emissions

3	SECTION 2.	(a) "Covered entities" means agricultural companies, electrical power

A Bill to Require the Single Transferable Vote System

1	BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
2	Section 1. The voting system will be changed to the single transferable vote system
3	rather than the current voting system.
4	Section 2. The single transferable vote is defined as a type of voting system that
5	involves the voter ranking candidates on a list rather than voting on a single canidate.
6	A. The voter may rank as many people as there are on the ballot, and cannot put a
7	candidate's name twice on a ballot.
8	B. The voter does not have to rank every candidate, and can choose not to put two
9	or more candidates on the ballot.
10	Section 3. This policy will be enforced and the votes will be counted by individual
11	state governments. If any city uses a different voting system, they will be fined 100 U.S.
12	Dollars for every vote counted, and the votes will not be used in any way by any party.
13	A. The votes will be counted as such: A quota will be used to determine the
14	number of votes needed to be elected into an office. The process for counting the
15	votes are divided into stages based on the number of candidates. In the first stage
16	the candidate that is on the top of each voter's ballot is counted, and all other
17	rankings are ignored. If a candidate does not reach the quota, the second stage of
18	counting will begin, in which the candidate with the least number of votes will be
19	excluded, and any voter that had ranked that candidate's name on the top of their
20	ballot will have their vote changed to the person below that candidate (if they 21
21	have a name below that). The counting process will be the same in the second
22	stage as it is in the first stage. If a candidate does not reach the quota in the second
23	stage, the vote counting process will continue as it did in the second stage, until
24	the quota is reached.
25	B. The quota is the number of votes divided by the number of seats plus one.
26	C. If the number of votes is even , one extra vote will be added to the quota to
27	avoid a tie.
28	Section 4. This legislation will take effect on November 30, 2023. All laws in
29	conflicts with this legislation are hereby declared null and void.
